



## 2020-2021 Dues & Fees

---

### Golf Membership

The Golf Membership is an annual, non-equity, full privilege membership which includes access to the Golf Course, Driving Range and Practice Area, Fitness Center, Tennis Center, Pool, Dining and Special Events. The Membership Year is October 1 to September 30.

Initiation Fee (one time, non-refundable)	\$15,000
Annual Dues (option to pay quarterly incurs an administrative fee which is payable with the first installment)	\$12,000 – Family \$10,000 – Single
Golf Activity Fee (required; includes locker)	\$200 – Family \$125 - Single
Annual Holiday Fund (required for all memberships)	\$150
Food & Beverage Minimum (unused minimum is charged to credit card on file at the end of the membership year)	\$1,100 – Family* \$700 – Single*

### Associate Golf Membership

The Associate Golf Membership is an annual, non-equity, full privilege membership which includes access to the Golf Course, Driving Range and Practice Area, Fitness Center, Tennis Center, Pool, Dining and Special Events. The Membership Year is October 1 to September 30. To qualify, the primary member must be **between the ages of 18 and 45** at the time of joining, and neither the primary member nor the spouse/significant other may have held previous membership at the Club.

Initiation Fee (non-refundable; initiation fee is paid in annual installments using a formula based on age at joining, with a minimum payment of \$1,500 per year)	\$15,000
Annual Dues (includes complimentary cart fees; option to pay quarterly incurs an administrative fee which is payable with the first installment)	\$7,500 – (Family or Single )
Golf Activity Fee (required; includes locker)	\$200 – Family \$125 - Single
Annual Holiday Fund (required for all memberships)	\$150
Food & Beverage Minimum (unused minimum is charged to credit card on file at the end of the membership year)	\$700*

***Quarterly Payments are available for Golf Memberships Only and are subject to a \$500 administrative fee, payable with the first quarter dues.***



## Sports Activity Fee

The Sports Activity Fee is an annual, non-equity, family fee which includes access to the Fitness Center, Tennis Center, Pool, Dining social activities and Special Events.

**December 1<sup>st</sup>- April 30<sup>th</sup>** : Sports Activity Fee holders are afforded **ten** 18-hole rounds of golf per Membership, at the prevailing Sports Rate **(\$100)** (**Play is restricted to after 1:00pm**: no tournament play with the exception of 9 & Dine events and Couples Events. Every play counts. 9-hole rounds count as a half round. Guests pay the \$125 unaccompanied guest rate. Use of the practice facilities is restricted to the date of play.

**May 1<sup>st</sup>- November 30<sup>th</sup>** : Sports Activity Fee Holders are afforded **fifteen** rounds of golf, **after** 10:00 am at the prevailing summer guest rate. Use of the practice facility is restricted to the date of play.

The billing Cycle is December 1 to November 30 and dues must be paid in full.

Sports Activity Fee	\$3,500
Annual Holiday Fund (required for all Sports Activity Fee Holders)	\$150
Food & Beverage Minimum (unused minimum is charged to credit card on file at the end of the membership year)	\$500*

## Social Activity Fee

The Social activity fee is an annual, non-equity, family fee which includes access to the Tennis center, pool, dining, social activities and special events year-round.

**May 1<sup>st</sup> through September 30<sup>th</sup>**: Access to the Fitness Center and Fitness classes is available

Social Activity Fee Holders May Play up to **(6) Rounds of golf during the annual billing cycle** at the prevailing guest rate. The billing cycle is December 1 to November 30 and dues must be paid in full.

Annual Holiday Fund (required for all Social Activity fee holders)	\$150
Food & Beverage Minimum (unused minimum is charged to credit card on file at the end of the membership year)	\$500*

Golf Trail Fee (Privately-Owned Cart)	\$2,400 – Family \$1,900 - Single
Annual Cart Pass (Club Cart; Bag Storage Included)	\$2,700 – Family \$2,200 - Single
Golf Member Cart Fee	\$30 per person
Extended Family Golf Fee (includes Cart) <i>Extended Family Juniors - up to age 15 - are eligible for the member cart fee rate after 1:00pm</i>	\$65
Accompanied Guest Golf Fee (includes cart)	\$100
Unaccompanied Guest Golf Fee (includes cart)	\$180
Bag Storage	\$100 per bag
Sports Member Golf Fee (includes cart)	\$100
Sports Member Golf Guest Fee (includes cart)	\$125
